CRITERIA & RULES

- Volunteers must be 18 years old or older
- Volunteers must be legal residents of Utah County
- Volunteers must volunteer a minimum of two hours a week during the following hours:
 - Monday: 11:00 am 5:00 pm
 - Tuesday: 11:00 am 5:00 pm
 - Thursday: 11:00 am 5:00 pm
 - Friday: 11:00 am 5:00 pm
- Volunteers must wear ID Badge at all times while volunteering
- Volunteers can only walk adoptable dogs or interact with adoptable cats
- Volunteers must be wearing closed-toe shoes (no flip-flops, sandals, crocs, etc.)
- Volunteers must be physically able to handle and control the animals at all times
- Volunteers must sign in and leave their vehicle keys at front desk prior to volunteering
- Volunteers agree to make no public statements critical of North Utah Valley Animal Services, their employees, or operations
- Volunteers may be denied participation at any time, without notice, at the sole discretion of North Utah Valley Animal Services

Volunteer Code of Conduct: As a volunteer I will perform only those assigned tasks that are within my physical capability and will not undertake any tasks that are beyond my physical capability or ability. I will not undertake to use any equipment or tools that I am unfamiliar with or have not been trained to operate properly and safely. As a volunteer I will strictly observe all safety rules and use care in the performance of my assigned tasks. As a volunteer I will treat everyone with respect, loyalty, patience, integrity, courtesy, dignity and consideration. While volunteering I will not use profanity, or make humiliating, ridiculing, threatening, or degrading statements.

Volunteer Acknowledgements and Waivers: To help safeguard the animals, staff, and public, North Utah Valley Animal Services may perform a background investigation on all volunteers. As a condition of volunteering, I give North Utah Valley Animal Services permission to conduct a thorough background investigation on me, which may include a review of sex offender registries, criminal history records, driving records and federal FBI records. I understand that all volunteer positions are conditioned upon North Utah Valley Animal Services never receiving inappropriate information on my background. I further understand that all volunteer appointments are made and withdrawn at the sole discretion of North Utah Valley Animal Services and I agree to willingly abide by their decision. I agree to make no public statements critical of North Utah Valley Animal Services, their employees, or operations.

I understand that volunteer positions are charitable contributions to North Utah Valley Animal Services without anticipation of compensation of any kind or consideration of future employment. As a volunteer I agree to be subject to the policies and procedures of North Utah Valley Animal Services. I further understand that North Utah Valley Animal Services may permit or deny my participation as a volunteer at any time at their sole discretion.

I understand that there are inherent risks, including risk of personal physical harm, injury, and death, associated with handling animals and volunteering at North Utah Valley Animal Services. These risks may include, but are not limited to, animal bites, accidents, injuries, and personal property damage. On behalf of myself, my heirs, agents, personal representatives, and executors, I hereby release, discharge, indemnify, and hold harmless North Utah Valley Animal Services and its agents, servants, employees, and board members from any and all claims, causes of action, or demands, of any nature or cause connected with my volunteer activities and duties. This may include attorney fees, court costs, and other costs incurred by North Utah Valley Animal Services in connection with my volunteer service based on damages or injuries which may be incurred or sustained by me in any way.
